ALL ATTENDEES MUST BE FULLY VACCINATED. TO OBTAIN YOUR TRINIDAD AND TOBAGO TRAVEL PASS HERE: [Trinidad & Tobago - Travel Authorisation \(ttravelpass.gov.tt\)](https://ttravelpass.gov.tt). *You will need a negative test before accessing this website.*

OTHER INFORMATION TO NOTE WHEN TRAVELLING TO TRINIDAD & TOBAGO

1. Non-Nationals who are NOT FULLY VACCINATED will NOT be allowed entry into Trinidad and Tobago at this time.
2. Travellers may begin the Application process 72 hours before arrival in Trinidad and Tobago.
3. All Travellers (including minors) must submit A NEGATIVE NASOPHARYNGEAL (Nasal Swab) RT-PCR or NEGATIVE Antigen Test Result taken NO EARLIER than 72 Hours PRIOR TO ARRIVAL IN TRINIDAD and TOBAGO. Proof of this must be presented to the relevant authorities prior to boarding of their flight and upon arrival in Trinidad and Tobago. **The PCR Test must be in English ONLY.**
4. Individuals are considered FULLY VACCINATED if 14 days have passed since receiving either a World Health Organisation (WHO) Approved single dose Vaccine OR the second dose of a WHO Approved 2 dose Vaccine. 5. Proof of this must be presented to the relevant authorities prior to boarding of their flight and upon arrival in Trinidad and Tobago.
6. Travellers who are NOT FULLY VACCINATED will be required to enter MANDATORY 7 Day Quarantine and submit to PCR Retesting at an APPROVED STATE SUPERVISED QUARANTINE HOTEL ([click here for list](#)), at their own expense. Proof of this must be presented to the relevant authorities prior to boarding of their flight and upon arrival in Trinidad and Tobago. All accommodation arrangements must be confirmed BEFORE beginning the application process.
7. **We advise all applicants to visit the FAQ Section for further information.**

8. The receipt of TTravel Pass does not guarantee access to the flight nor entry into Trinidad and Tobago. All travellers are still subject to the validation processes of the airlines and Border Control Authorities in Trinidad and Tobago.
9. Masks are to be worn at all times in public. Failure to wear a mask renders the person subject to a Public Health Fixed Penalty Fine.
